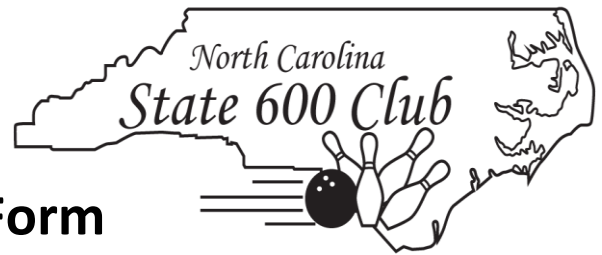


# NCS Women's 600 Club
